I, on behalf of the below named child/children (inclusively hereinafter referred to as "CHILD") HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge Rumble Tumble and its agents, employees, officers, directors, affiliates, successors and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I or CHILD ever had or may have, arising from or in any way related to CHILD'S participation in any of the events or activities conducted by, on the premises of, or for the benefit of Rumble Tumble provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct.

By this waiver, I, on behalf of said CHILD, assume any risk, and take full responsibility and waive any claims of personal injury, death or damage to personal property associated with Rumble Tumble including but not limited to receiving lessons at the facility, using the facility and its equipment in any manner, form or fashion, and practicing and/or engaging in gymnastics and tumbling activities on and off the premises.

I agree it is my responsibility to assure that said CHILD has the necessary and requisite skills to participate in all facets and activities of and requested of the child's gym and play facility. I understand it is my responsibility to supervise said CHILD and to spot said CHILD on all gym equipment and to enforce gym safety rules at all times. I understand that the activities that said CHILD will participate in may be considered inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. On behalf of myself, my heirs, assigns and next of kin, I and said CHILD waive all claims for damages, injuries, and death sustained to me, CHILD, or property, that I or CHILD may have against the aforementioned released party to such activity.

This WAIVER AND RELEASE contains the entire agreement between the parties, and supersedes any prior written or oral agreements between them concerning the subject matter of this WAIVER AND RELEASE. The provisions of this WAIVER AND RELEASE may be waived, altered, amended or repealed, in whole or in part, only upon the prior written consent of all parties. The provisions of this WAIVER AND RELEASE will continue in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of, Rumble Tumble whether by agreement, by operation of law, or otherwise.
